## Background

One of the world's largest independently owned advertising agencies needed to strengthen its ransomware and proprietary data protection processes. Their on-prem process relied on third-party solutions that were slow to respond and provided inaccurate data that was out-of-sync with their needs — resulting in a higher potential for end-user data gaps and non-compliant processes.

This system did not support its global workforce, and it also didn't adapt well to hybrid and remote work.

Further compounding the problem, data could only be drawn from a subset of devices. This made it impossible for the agency to fully understand and report what intellectual property was and was not protected.

## Complicated and inconsistent data retention

Before CrashPlan, the agency's processes relied on a solution that didn't adapt to its shifting tech needs. The solution only provided protection for Windows devices, and it also required physical media to restore the agency's data. **"If someone's machine blew up, our previous solution said they'd send the data on a CD. It took seven weeks. When the data finally did arrive, it was the wrong data,"** said the IT administrator for the program. With this process, the agency was left vulnerable to data breaches and ransomware attacks.

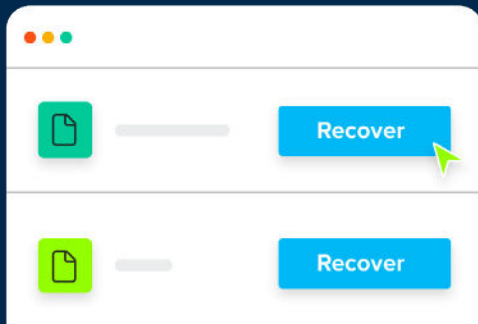

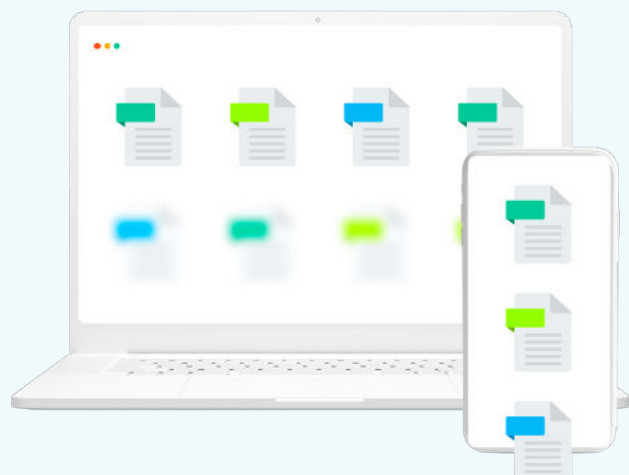
